CIRCULAR

Invitation for Proposals for Third Party Evaluation of Civil Works Under Sarva Shiksha Abhiyan, Delhi

Sarva Shiksha Abhiyan (SSA) is a flagship programme of the Govt. of India, an effort to Universalize Elementary Education in response to the demand for quality basic education all over the country.

One of the important interventions in SSA is Civil Works. So far SSA has taken the initiative of providing 1238 Additional Classrooms (ACR), 10 school building, 6 DURCC rooms & 610 toilets to various schools MCD and Directorate of Education.

The work is being executed by Delhi State Industrial & Infrastructure Development Corporation Ltd. (DSIIDC), a Govt. of Delhi Enterprise.

However, as per the requirement of MHRD, third party evaluation is mandatory. It is necessary to engage an independent Agency to undertake the day to day inspection of the sites where construction work is being under taken. This agency should be in direct contact with the SPD/DPC office. The Third Party Inspections team and the proposed technical staff should also be asked to certify the quality of material being used for the construction activity.

Offers are invited from Govt./PSU/ Reputed Technical institution/organization for rendering **third party services** for construction of Schools and Additional Class Rooms in various schools under Directorate of Education and MCD located in NCT of Delhi, under Sarva Shiksha Abhiyan of Department of Education Delhi, latest, by **27.11.09 upto 3.00 pm** at the above address and these shall be opened on the same day at 3:30 pm. The Approximate cost of the Civil Works project is about 9.5 Crore.The work is proposed to be executed by Delhi State Industrial & Infrastructure Development Corporation Ltd (DSIIDC) a Govt. of Delhi Enterprise.

The period of completion of work is six months from the date of award of work by DSIIDC or till the completion of the project which ever is later. Third Party inspection is required at following stages of construction:-

- 1. Foundation level
- 2. Plinth level.
- 3. During construction
- 4. Roof level.
- 5. After completion.

During the course of site visit, the third party has to inspect the work at above mentioned stages of the construction work or as per the requirement of SSA and the material available at site and has to produce its inspection report after conducting required mandatory testing. The payment shall be made proportionately in three parts on production of bill supported with the inspection report. The SSA reserves the right to accept/reject the offers without assigning any reason there of.
