The undersigned is directed to refer to this Department's O.M. of even No. dated 19<sup>th</sup> March, 2009 revising the Dearness Allowance w.e.f. 1.1.2009 in respect of employees of Central Government and Autonomous Bodies who continue to draw their pay and allowances in the **pre-revised scales of pay** as per 5<sup>th</sup> Central Pay Commission.

- The rates of Dearness Allowance admissible to above categories of employees of Central Government and Central Autonomous bodies shall be enhanced from the existing rate of 64% to 73% w.e.f. 1.7.2009. All other conditions as laid down in the O.M. dated 3<sup>rd</sup> October, 2008 will continue to apply.
