Subject: Annually conditional renewal of the **National Means-Cum Merit Scholarship Scheme**
(NMMS) scholarship 2007-08 & 2008-09 Reg.

Sir/Madam,

In continuation of this office letter No.2666/sc dated 31.07.2009, whereby you were informed about the NMMS awardee students of your school to follow certain conditions for continuation of the NMMS scholarship up to next 4 years. The Second batch (D.O.E. 16.11.2008) for 2008-09 under this scheme also has come in to existence since 2009. As you all are well aware that the Scholarships, under this scheme is to be awarded to the selected candidates for the 4 consecutive academic years i.e. class IX, X, XI, XII. This scholarship will be annually renewed subject to the student concern fulfills the certain conditions set up by the MHRD. Govt. of India as given below:

1. The student should be promoted from IX class to X class and from XI class to XII class with minimum of 55 % marks (for Gen category) and 50 % marks (for reserved categories) in one attempt only.
2. The student should be promoted from X class to XI class with minimum 60 % marks (for Gen category) and 55 % marks (for reserved categories) in one attempt only.
3. Student should continue with his/her study in Govt/Local Body/ Govt.aided School.
4. The awardee student pursues his/her studies on a whole/regular basis in approved courses in the jurisdiction of Delhi/New Delhi.

You are, therefore, requested to maintain a chart of the selected candidates in the NMMS 2007-08 and 2008-09 of your school for coming 4 academic sessions and check by applying the conditions as 1 to 4 above. If the awardee does not fulfill the requisite conditions, no scholarship shall be awarded to him/her. This office should be informed immediately for such cases in detail and practice like this be repeated quarterly so that the scholarship may be stopped as and when the candidate is declared "**ineligible**". Scholarship once discontinued cannot be revived under any circumstances.
