Sub:- Regarding obtaining License for operationalisation of swimming pools.

Sir/Madam,

Kindly refer to the letter dated 9.7.2010 from Addl. Commissioner of Police Licensing and this office letter no. DE.41/Swimming / 2010 / Sports / 2605-2664 dated 21.06.2010 on the above mentioned subject.

The Principal / HOS of the schools where swimming pools are located were requested to apply for the swimming pool license from Addl. DCP (Lic.) Delhi. It has been observed that the above schools are yet to apply for the license for want of clarification.

Hence, it is further requested that all the respective Principal / HOS are to immediately apply for License to operate the swimming pools located within their school premises. They are to fulfill all the requirements / norms laid down by ACP (Lic.) Delhi i.e. Application forms with Principal / HOS photographs, affidavit duly filled by the Principal / HOS, photo of swimming pool, site plan, ownership and also enclose the water testing report from PWD / DSIIDC.

The swimming pools are to be operated strictly in accordance with the norms laid down for applying for License.

This may be treated as **"MOST URGENT"**.
