Sub: - Revision of Rate in Govt./Govt. Aided school in r/o upper Primary classes & an provision of honorarium to cook cum helper under National Programme for Mid Day Meal.

Sir,

I am hereby directed to inform you that Cooking Cost of Mid Day Meal in r/o Upper Primary classes have been revised. The revised norms & rates vide F.No.1-1/2009-Desk (MDM) dated 24.11.2009 of Ministry of HRD are as under:-

i. Revision of the food norm for Upper Primary children by increasing the quantity of pulses from 25 to 30 grams, vegetables for 65 to 75 grams and by decreasing the quantity of oil and fat from 10 grams to 7.5 grams.

The food norm after this revision would be as under:-

Sr. No.	Items	Quantity per day	
		Primary	Upper Primary
1.	Food grains	100gms.	150 gm.
2.	Pulse	20gm.	30gm.
3	Vegetables(leafy also)	50gms.	75gms.
4	Oil & fat	5gm.	7.5gms.
5	Salt & Condiments	As per need	As per need

ii. Enhancement of the cooking cost (excluding the labour and administrative charges) for primary to Rs. 2.50 and for upper primary to Rs. 3.75. Now, the cooking cost would include the cost of pulses, vegetables, oil & fats, salt & condiments and fuel.

iii. The cooking Cost will be further revised by 7.5 % on 01.04.2010 and again on 01.04.2011.

The revised rates will be applicable Govt. /Govt. Aided Schools of Directorate of Education w.e.f. 15.01.2010.
