Madam,

Kindly refer to Letter No. D/DEO/Admn./HQ/10/1316 dated 22.01.10 of the Additional Dy. Commissioner (Education), MCD (copy enclosed) vide which it was informed that Dy. Education Officer (Admn. & TRC) has requested to the Zonal Dy. EOs to submit a list of any left-out Assistant Teachers for promotion to the post of TGT/TGT(MIL) who are coming within the consideration zone of 31.01.10 for onward transmission to the Directorate of Education. Vide the said letter, it has also been requested that if the Directorate of Education extends the cut-off date to 01.01.09 instead of 01.01.08, then more applicants will come in the zone of consideration and rest of the vacancies can be also be filled up.

In this regard, I am directed to inform you that a meeting of the Departmental Promotion Committee was held on 11.02.10 and DPC was of the view that MCD may be given one more final opportunity to send the applications/dossiers of eligible candidates for considering them for the above mentioned posts with cut-off eligibility date as 01.01.09 instead of 01.01.08 as per recruitment Rules.

It is, therefore, requested to kindly circulate the revised eligibility cut-off date so that more eligible candidates can apply and their cases can also be considered for promotion at this end as per Recruitment Rules. However, it may kindly be ensured that the applications/dossiers duly completed in all respect i.e. applicants having completed 5 years regular service as on 01.01.09 alongwith their service particulars i.e. ACR Grading (2004-05 to 2008-09), Work & Conduct Report/Integrity Certificate and VCR in the order of their seniority No. in the consolidated proforma are submitted to this office latest by **05.03.2010**. Attested photocopies of marks-sheet of Graduation for all years and other certificates may also be attached. Those candidates who have already applied against vacancies for the year 2008-09 need not apply afresh.


If the required information is not received within the stipulated date, it would be presumed that there are no such eligible Asstt. Teachers in MCD and accordingly, the D.P.C. will be held and the remaining vacancies shall be filled up by Direct Recruitment through DSSSB as per the norms laid down in the RRs to the post of TGT/TGT(MIL). This Department will not be responsible for any consequences, if any arise, at later stage.

You are also requested to send a fresh consolidated seniority list in the form of a hard copy as well as a soft copy in respect of 1720 Asstt. Teachers whose dossiers have already been sent earlier and those whose dossiers are yet to be sent by your Department upto 05.03.10 so that they all can be considered together by the D.P.C. to avoid any dispute of seniority at a later stage. A Hard disk of the above information may also be made available.

Kindly accord "TOP PRIORITY" as the matter regarding filling of vacancies of teachers is being monitored at the level of Hon'ble High Court/Supreme Court.



Sir/ Madam

I am directed to inform you that **2626** vacancies are available for the promotional posts of TGT/TGT(MIL) which are to be filled up from the Asstt. Teachers of MCD Primary School against the vacancies for the year 2008-2009. The number of category wise, subject wise and gender wise vacancies are enclosed herewith **Annexure-C**. Maximum Number of Candidates who come in the consideration Zone and are to be sponsored by MCD have also been indicated against each in the Annexur- C . The names may be forwarded as per latest instructions/guidelines of DOPT.

You are, therefore, requested to send the applications of eligible Asstt. Teachers of your primary school having 5 years regular service as on 01.01.2008 , alongwith their service particulars i.e. ACR grading (20004-05 to 2008-2009), work & conduct Report/ Integrity Certificate, VCR in the order of their Snty. No. in the consolidated proforma latest by 30.06.2009. The cut off date of eligibility conditions shall be 01.01.2008. Attested photo copies of marks sheets of graduation for all years and other certificates may also be attached . The application form has been modified and the applications may be accepted in the enclosed proforma, the application filled in old form will not be accepted.

Single application form may be filled and options may be exercised in the same form as per their choice and eligibility. All the applications should be forwarded to this office after entering the particulars of the candidates as per the proforms enclosed as annexure C in a single lot and subsequent supplementary lists will not be accepted in any circumstances. Incomplete applications in respect of ACR/VCR /IC/WCR/Snty No. /copies of marks sheet etc will not entertained.

It may be ensured that the teachers who have not accepted promotion may be debarred for one year and their applications may not be considered. Further the second choice filled by the candidates may be considered and entered in the consolidated list only up to the last seniority no. considered in the particular subject / category.

The consolidated list of applications may be forwarded on compact disk (CD) / workable floppy ( Data In Excel ) along with a hard copy as per proforma ( Copy enclosed.) separately for male and female Asstt. teachers duly signed by Competent Authority. The MCD authorities will be responsible for incorrect information filled in the consolidated list . It is clarified that no previous list / applications will be considered for these posts and all the willing candidates should be informed that they will have to apply afresh in the modified proforma.
