In continuation of this Office Letter No. DE3(57)/E-III/Notification/ 2009-10/1468-73 dated 16.02.2010, I am directed to inform you that the last date for sending applications/dossiers, duly completed in all respect, of the candidates with eligibility cut-off date as 01.01.2009, may be read as **26.02.2010** instead of **05.03.2010** in the said letter dated 16.02.2010. It is also requested that the applications/ dossiers may be sent to this office on day-to-day basis alongwith necessary information/documents as referred to in the aforesaid letter dated 16.02.2010 for further necessary action at this end as the date of D.P.C. has already been fixed for 02.03.2010.

It is further informed that this Department will not be able to consider the applications/dossiers received after the stipulated date i.e. **26.02.2010** as the date of D.P.C. has already been fixed and it would be presumed that there are

no further eligible Assistant Teachers in MCD and accordingly, the D.P.C. will be held and the remaining vacancies shall be filled up by Direct Recruitment through D.S.S.S.B. as per the norms laid down in the RRs to the post of TGT/TGT (MIL). This Department will not be responsible for any consequences, if so arisen, at later stage.

It is reiterated that this matter may kindly be accorded "TOP PRIORITY" as the issue regarding filling of vacancies of teachers is being monitored at the level of Hon'ble Supreme Court/High Court.
