ORDER


Hon'ble Delhi School Tribunal vide Order dated 01/12/2009 in appeal Nos.-31 to 35/2009 has directed the Directorate of Education to take necessary steps to ensure that Contracts of Service of all the employees in recognized unaided minority schools in Delhi are filed and registered with Administrator as provided in Section 15 of Delhi School Education Act-1973 read with Rule 130 of Delhi Education Act -1973 within a period of 3 months from the date of this order. A report be submitted within 4 months regarding action taken by the Department.

Relevant portion of the order of Tribunal dated 01/12/09 is reproduced below:-

“Another aspect of the matter is non compliance of Section 15 of Delhi School Education Act read with rule 130 of Delhi School Education Rule, 1973 by majority of recognized unaided minority schools. In most of the cases before this tribunal of minority school, it has been noticed that Contracts of Service are not registered with the administrator by these schools. Directorate of Education is hereby directed to take necessary steps to ensure that Contracts of Service of all the employees in recognized unaided minority schools in Delhi are filed and registered with administrator as provided in Section 15 of Delhi School Education Act-1973 read with Rule 130 of Delhi School Education Rules-1973 within a period of 3 months from the date of this order. A report be submitted within 4 months regarding action taken by department.

In view of the above order of Hon'ble Delhi School Tribunal all Un-aided Minority Recognized Schools are hereby directed to ensure that Contracts of Service of all the Employees in Recognized Un-Aided Minority School in Delhi are filed and Registered with Directorate of Education with the District Deputy Director of Education concerned. Compliance report may be submitted by each and every Un-aided Minority Recognized School to concerned DDE within 15 days from today i.e. latest by 31/03/2010.

Non-compliance of order will be viewed seriously.
