As 2552 applications have been received in this Directorate forwarded by various Department of Govt. of NCT of Delhi, and accordingly a tentative eligibility list (as per date of appointment) of Group 'D' employees has been prepared for promotion to the post of Laboratory Assistant. If no objection/request for removing the objection received within stipulated period it will be assumed that they have nothing to say in this regard and tentative eligibility list will be treated as final after removing the objections, so received.



All Group "D" employees of the tentative eligibility list are advised to check their particulars and submit the objection/complete the short falls as mentioned against their names in the list through their concerned competent authority along with attested copy of supporting documents, if any, within 15 days i.e. by 05/06/2010.

It is made clear that no objection will be entertained by this Directorate after the stipulated date.
