NOTIFICATION

No. F. 12(3)/Fin(T&E)/2009-10: In exercise of the powers conferred by sub-section (1) of section 22 of the Delhi Tax on Luxuries Act, 1996, (Delhi Act 10 of 1996), the Lieutenant Governor of the National Capital Territory of Delhi, being satisfied that it is necessary to do so in the public interest, hereby, exempts the following persons or class of persons from payment of Luxury Tax on the Luxury to be paid in the Hotels from the 20th February, 2010 to the 16th March, 2010 in the National Capital Territory of Delhi, namely:-

1. Officials of Federation of International Hockey (FIH), Event Officials, Participating teams of 'Hero Honda Men's World Cup Hockey -2010' to be organized by Hockey India and Organising Committee FIH World Cup in New Delhi from 28th February 2010 to 13th March, 2010.

2. The exemption is granted subject to the following conditions:-

- a) The Hockey India or Organizing Committee Hero Honda FIH World Cup-2010 shall provide to the Commissioner (Luxury Tax) a detailed list of officials of Federation of International Hockey, Event Officials, Participating Teams, room wise/hotel wise along with period of stay and tariff paid in the Hotel, so as to ascertain the exact amount of Luxury Tax on which exemption is to be allowed.
- b) The Hockey India or Organising Committee Hero Honda FIH World Cup-2010 shall issue a certificate to the hotel along with the list of officials of Federation of International Hockey, Event Officials, Participating Teams entitled for such exemption and such hotel shall enclose the aforesaid list and certificate issued by the Hockey India or Organising Committee Hero Honda FIH World Cup-2010 and the copies of the bills raised by the Hotel with their Luxury Tax returns in Form 8 for the months of February and March, 2010. The Hotel shall also furnish the turnover on accommodation provided to the persons so entitled for exemption in column 1 (B) of Form 8 as prescribed under Delhi Tax on Luxuries Rules, 1996 for the months of February and March, 2010 while claiming exemption from payment of Luxury Tax on the basis of this Notification.
