No.F10(4)/Fin(Rev.-I)/2010-11/ In exercise of the powers conferred by section 58 of the Punjab Excise Act, 1914 (Punjab Act 1 of 1914) as extended to the National Capital Territory of Delhi, the Lieutenant Governor of the National Capital Territory of Delhi is pleased to make the following rules further to amend the Delhi Liquor Licence Rules, 1976 and since it is considered that they should be brought into force at once, he is further pleased to direct that they shall come into force without previous publication, namely:-
