

2. Further, vide above said Orders of Department of Information Technology, Government of NCT of Delhi, e-Procurement system was made compulsory in 73 organizations of Government of NCT of Delhi. The list of organizations which are covered in e-Procurement system is enclosed as Annexure-I.

However, as per MIS report of e-Procurement system, it is seen that 23
Department's have floated 7500 tenders till date on e-Procurement system.

4. All the organization's covered in e-Procurement system are again directed to ensure that e-Procurement system should be compulsorily implemented for all tenders over Rs.2 lakhs in their Department's, office's, sub office's, field office's etc.
