the decisions of the last meeting held on 5<sup>th</sup> June 09 at Raj Niwas. During the review, Hon'ble Lt. Governor gave the following directions:-

inspect warehouses and godowns in their respective areas of jurisdiction along with Delhi Fire Service team and submit their reports within six weeks. The godowns located on agricultural land will also be inspected to ensure safety of the people working there and residing in the neighbourhood. Godowns operating from unplanned industrial areas will also have to obtain the necessary statutory

clearances. A synergical approach is required to be taken by the concerned agencies i.e. Fire, MCD, Labour, Industries and Environment in this regard. This action needs to be completed within a period of 90 days and a feed back is to be given by the concerned DCs to the Divisional Commissioner. Hon'ble LG directed that a notice in this regard be published in the media by the Divisional Commissioner.

(Action: Divisional Commissioner, All DCs, DFS, Secy.(Labour), Secy.(Industry), Secy.(Environment) and Commissioner, MCD)

☆ The Fire Department is to inspect all godowns and take appropriate action against storing of hazardous and inflammable material.

(Action: Director-Fire Service)

An audit of response time and efficiency of response of various stakeholders during mock drills should invariably be carried out by the Indian Army (Rep. of GOC Delhi Area).

(Action: Rep. Of GOC Delhi Area)

☆ Surprise mock drills need to be carried out by all District and Delhi Disaster

Management Authorities.

(Action: Dvl.Commr., All DCs, GOC Delhi Area)

Lists of civil defence volunteers at the district and state levels need to be updated immediately and call-out drills for civil defence volunteers need to be carried out by the Dy. Commissioner at regular intervals. Civil defence volunteers need to be given basic rescue training in cordoning off the area, carrying injured on stretchers, etc. to empower them to meet any eventuality, specially during the Commonwealth Games.

(Action: All DCs and Dvl. Commr., & DG Civil Defence)

A scheme may be formulated for survey of structurally unsafe buildings and grant of incentives for retrofitting to make these safe.

(Action: Commr.MCD, Div.Commr.)

A Emergency Operation Centres (EOC) are to be made functional in all districts by end of December 09. The district EOC should be equipped with basic search and rescue equipment necessary for saving lives.

(Action: Div. Commr. & All DCs)

☆ Workshops for sensitizing media of their role and responsibility and code of conduct to be followed by them in times of any disaster should be organized regularly.

(Action: Dvl. Commissioner)

Representatives from police and MCD are to attend disaster management meetings and participate in mock drills organized by the District and Delhi Disaster Management Authorities. Non-attendance by members of District Disaster Management Authorities needs to be dealt severely with disciplinary action against defaulters.

(Action: C.P., Commr.MCD, Div. Commr. & all DCs)

Incident Command System needs to be incorporated in District Disaster Management Plans. Draft for the same is to be submitted by each District Disaster Management Authority to the Divisional Commissioner. All stakeholders are to extend unqualified support to the Incident Commander at the district level i.e. the Dy.Commr. (Revenue).

(Action: Div. Commr. and all DCs & HODs Of Delhi Police, DDA, MCD, NDMC, Industry, Labour, Environment)

3. The Hon'ble LG directed that a team from Delhi Traffic Police should visit Sanjay Gandhi Transport Nagar and prepare a traffic circulation plan as part of Creative Solution Unit (CSU) at the earliest.

(Action: Jt.C.P. Traffic)

- 4. Hon ble LG desired that at the next meeting, the focus will be on disaster management at sports venues in the context of the Commonwealth Games 2010.
- 5. There being no other point, the meeting ended with a vote of thanks to the Chair at 1300 Hrs.
