As we are aware that Commonwealth Games are scheduled to be held from 3rd Oct. to 14th Oct. 2010 and test events for Gymnastics and Cycling are scheduled to be held from 17th to 25th July - 2010 at Indira Gandhi Indoor Stadium. As per the Circulation Plan of CWG-2010, as sent by DCP (Central), during the period from 14th July to 25th July 2010 and from 15th September to 14th October - 2010, no vehicle will be allowed to be parked in the parking area in front of Delhi Secretariat Building.

Further during the Test Events and Commonwealth Games, only the vehicles of Delhi Govt. and private vehicles of staff members, which will have valid parking labels, issued from GAD, will be allowed entry after checking at the vehicle checking points. The entry shall be allowed only from Vikas Marg/ITO side and no vehicle will be allowed entry from Rajghat Crossing to Delhi Secretariat Building.
