Sir / Madam,

Please find enclosed a copy of D.O. Letter dated 6th August, 2010 of Shri Shailesh Gandhi, Information Commissioner, Central Information Commission addressed to the Chief Secretary, Delhi on the subject mentioned above.

2. It has been informed that it has come to the notice of the Commission that a lot of information relating to tenders issued for the Commonwealth Games and other development work in Delhi in the last five years is not available in public domain and disclosures under Section 4 of RTI Act, 2005 have not been made in this regard.

3. It has further been observed that as per the websites of different departments of Delhi Government like MCD, NDMC, Urban Development, PWD, Rural Development, Irrigation and Flood Control, Delhi Jal Board, DSIIDC etc. who are responsible for implementing these projects that certain disclosures have not been made till date. The Commission, has therefore, directed the Delhi Government to fulfill its obligations under the RTI Act and specifically make the information related to tenders in the prescribed format and make the information available in the websites of the concerned Departments latest by **15th September, 2010**. A report in this regard may also be sent **directly** to Central Information Commission by **20th September 2010** with a copy to AR Department.

4. You may also send the report to rtimonitoring@gmail.com, which should include:-

- (i) Measures taken to fulfill disclosure obligations under Section 4 including making information available on your official website.
- (ii) Measures put in place to ensure regular updating of the information uploaded on the websites.

5. All Principal Secretaries / Secretaries / Head of the Departments are requested to ensure proper compliance of the directions of the Central Information Commission. This may also be monitored regularly by all Heads of the Department, who will be responsible for its proper compliance.

Subject: *Suo moto* disclosure under Section 4 of the RTI Act, 2005

Dear Mr. Mehta

It has come to the Commission's notice that a lot of information relating to Tenders issued for the Commonwealth Games and other development work in Delhi in the last 5 years is not available in the public domain and disclosures under Section 4 of the Right to Information Act 2005 have not been made in this regard. As you are probably aware, disclosures in accordance with Section 4, RTI Act are crucial to ensure transparency and accountability in institutions. This would reduce the load of RTI Applications being filed with each institution as information would be freely available to citizens and they would not have to apply for it.

It appears from the websites of the different departments of the Delhi Government (ex. MCD, NDMC, Urban Development, PWD, Rural Development, Irrigation and Flood Control, Delhi Jal Board, DSIIDC etc.) who are responsible for implementing these projects, that certain disclosures have not been made till date. The Commission hereby directs the Delhi Government to fulfill its obligations under the RTI Act and specifically make the following information available by **15 September 2010**:

- Measures taken to fulfill disclosure obligations under Section 4 including making information available on your official website.
- Measures put in place to ensure regular updating of the information uploaded on the websites.

I look forward to your continued cooperation to make sure that the RTI Act is implemented in its full spirit in your institution.
