NOTIFICATION

In exercise of the powers conferred by sub-section (i) of section 12 of the Delhi Development Act, 1957(61 of 1957) read with notification of the Govt. of India in the Ministry of Health, Family Planning & Urban Development No.18011(28)/67-UD dated 14.02.69, the Administrator/Lt. Governor of National Capital Territory of Delhi hereby denotifies the Development Area of DDA given as under excluding the pockets/sub zones which have already been denotified.

115	10.19 Acres	<p>The Pocket is bounded by an irregular and zig-zag boundary. In the North West it has Chamelian Road. Starting from 'A' which is south-west corner of plot No. T-404 touching Chamelian Road boundary runs/turns along the existing road which touches plot No. T-404, T-391, T-292, T-280, T-275/E, T-258, double storey quarter No. 6403-5 north east corner of Tongawala Shed, T-460, T-480 and T-421 to reach point 'B'.</p> <p>From point 'B' move towards south east direction up to a distance of 75ft then in the north west up to a distance of 110ft, then in the north east to touch northeast corner of the existing school, then in the north west up to a distance of 115ft, then north west boundary of T-311 upto a distance of 200ft, then in a curvilinear shape to reach the point 'C'.</p> <p>From point 'C' move along the side of plots T-357, T-364, T-365 and then T-413, and then along Chamelian Road to reach the original point 'A'.</p>
135	10 Hectares	Asaf Ali Road in the South. Southern boundary of Zone A-13 & A-14 in the North. Ajmeri Gate towards West and Delhi Gate towards East.
145	90 Hectares	Industrial area and agricultural green belt in the East. Rohtak Road in the South. Railway line in the North.
