NOTIFICATION

Whereas the Lt. Governor, Delhi is satisfied that land is required to be taken by Government at the public expense for a public purpose namely for construction of new 765/400/220 KV ultra high voltage Sub-station to facilitate mega power to Delhi Capital region. Under the provisions of Section 7, of the said Act, the Land Acquisition Collector (South-West), Delhi is hereby directed to take orders for the acquisition of the said land.
