CIRCULAR

IMPORTANCE OF THE COURSE

In the recent past a trend has evolved through which civil society organizations have gained prominence in socio economic development discourse. Due to resource constrains the governments are seeking to deliver through synergic combination with civil society organizations. Media has also gained prominence in influencing government functioning. The present course on Good Governance, Civil Society and Media focuses on understanding role and contribution of civil society organizations and media and building synergic relations with them to fulfill socio-economic agenda of Govt.

TARGET BENEFICIERIES OF THE COURSE

The Course has been designed to benefit those who, while working in the Government, its local/autonomous bodies, public sector undertakings, are required to play managerial role and are responsible for good governance in their organizations. METHODOLOGY OF THE COURSE

The Course would be conducted by experts and experienced in the area of good governance. While lecture method would be generally followed, discussion and case examples may also be included in some sessions. The Course would be interactive and participants would be encouraged to raise questions and get the doubts cleared.
