I am directed to inform you that Central Information Commission has issued new instructions for filing online returns to the CIC under Section 25 of Right to Information Act, 2005. According to these instructions, from 2010-11 onwards, the Commission has decided to receive the online return from Public Authorities on quarterly basis. The quarterly return will be due immediately after the completion of every quarter and it will have to be uploaded on the website only i.e. <a href="http://www.cic.gov.in">http://www.cic.gov.in</a>. Henceforth the Public Authorities will not be able to submit the next quarter return without submission of the previous one, online.

All the public authorities therefore need a user ID & Password to submit the Quarterly Report directly to the CIC online, which will be issued by the AR Department. You are therefore requested to submit the requisite information pertaining to your department in the enclosed proformas within 10 days, so that User ID & Password can be prepared & sent to you to enable you to submit the consolidated quarterly report directly to the CIC online.

It may please be noted that there will be only one User ID and Password for one public authority & it will have to consolidate the reports of all PIOs & First Appellate Authorities on its own before uploading the information on the website.
