CIRCULAR

Subject: Recovery of sewerage charge from premises having disconnected or no water connections and continuing to be users of D.J.B's sewerage services.

DJB levies 60% of water charge towards sewerage maintenance charge in colonies and localities where sewerage facilities have been provided by D.J.B. However, there are about 1.32 lakh water connections disconnected on consumers request or due to non payment and it is likely that sewerage facility is continued to be used, as the erstwhile consumer meets his need of water through borewells or other means. The sewage facility would also be used where Water Connection have been disconnected

Thus, Delhi Jal Board exercising the powers under Section 55 of DWB Act, 1998 has decided to levy following sewerage charges w.e.f. 1-4-2011 in respect of premises having cut-off water connections and/or without DJB's water connections, but discharging their sewage into DJB's sewer lines:

Category of Consumer	Monthly Rate of Sewerage Charge proposed for unauthorized users of DJB's Sewerage services.(in Rs.)
Category-I & IA (Mixed use) (i) For premises having built up area upto 200 sq.m	Rs. 150/-
(ii) For premises having built-up area above 200 sq.n	Rs. 450/-
Category-II (Non-Domestic)	Rs. 1000/-
Category-IIA	
(i) Premises having built up area upto 500 sq.m	Rs.1000/-
(ii) Premises having built up area from 501 sq.m to 1000 sq.m	Rs.1500/-
(iii) Premises having built up area above 1000 sq.m	Rs.2500/-

The consumer/user shall be liable for action as per DJB Act for any violations. The above sewerage charges will not be applicable in following cases:-

- (1) Where the water connections in the same premises in the name of a consumer having more than one water connections has been disconnected such that at least one water connection remains in his/her name after disconnection. Provided there is only single sewer connection. However, in case there are more than one sewer connection the above specified charges shall be leviable against cut-off water connection with separate sewer connection in the same premises.
- (2) Where the disconnected water connection has been re-opened by D.J.B., the above charges would be withdrawn from the date of re-opening of the water connection.

All the ZROs will accordingly collect the data to enable computer section to generate the sewage charges from the consumers.
