
**Subject:- Extension of policy to calculate the water charges in respect of water connection installed in resettlement colonies- regarding**

In continuation to this office Instructional Order No. DJB/Jt.Dir(HQ)/2011/1921-2006 dated 17.02.2011 (copy enclosed) on the subject cited above, the existing policy to calculate the water charges in respect of various water connections installed in J.J. Resettlement Colonies under domestic category has been extended further till 31.12.2011.

All ZROs/Addl.ZROs are, therefore, directed to launch a special drive and issue notices to defaulting consumers to install functional water meters upto 31.12.2011, so that they may be billed as per their actual consumption of water and if meters are not installed upto the deadline, the old policy would again become operative.

This issues with the approval of the competent authority.



INSTRUCTIONAL ORDER

Sub: Revision in policy to calculate the water charges in respect of water connection installed in resettlement colonies - reg

In the interest of citizens, DJB has decided that, the policy to calculate the water charges in respect of various water connection installed in J.J. Resettlement Colonies stands revised w.e.f. 1.10.10 as under:-

- a. For each floor a provisional average of 15 KL per month will be taken where either the water meter is non-functional or has not been installed.
- b. Instead of combining the provisional average water consumption for all the floors in a particular property, the amount will be calculated for each floor separately and then added.
- c. The service charge while calculating the floor wise amount would be Rs 50/- instead of the normally applicable amount of Rs.100/- for water consumption between 11 and 20 KLs.
- d. Thus, the water charge would work out to be Rs.106 plus cess for each floor. This amount will be multiplied by the number of stories/floors in each such property in JJ resettlement colonies.
- e. This decision will be applicable only in respect of domestic consumers and action in respect of the commercial water connection in JJ resettlement colonies will be taken as per the existing policy guidelines.
- f. All the ZROs will launch special drive to issue notices to defaulting consumers to install functional water meters.
- g. Wherever the water charges have been deposited as per the previous policy, the same will be adjusted in the fresh water bills to be issued as per this revised policy w.e.f. 1.10.10.
- h. The revised scheme shall be applicable only for period ending 31.07.2011 and if meters are still not installed, the old policy would again become operative.
