Sub:- Rebate scheme for surcharge of Water & Sewerage Development Charges.

Delhi Jal Board, in its meeting held on 28th November 2011, has approved the introduction of scheme for granting rebate on component of **interest** accrued from time to time in respect of **water and sewer development charges** to the residents of the **colonies notified upto 31-05-2011** as under:-

Quantum of rebate :-

- **60% rebate to individuals**
- **70% rebate to the groups on the day of Site Camp** organized for this purpose.

Terms and Conditions of the above mentioned scheme will be as under:-


- (a) The rebate shall be applicable subject to payment of full amount of water/sewerage development charge **in lump-sum** excluding the rebate amount.
- (b) The plot holder is required to submit an application enclosing a self attested copy of proof in support of size of the plot to the concerned ZRO(W) and collect the bill from Z.R.O. office and make full payment on or before the stipulated date of scheme.
- (c) Cases where dues have already been paid in full i.e. principal plus interest, will not be re-opened in terms of the present proposal.
- (d) Further, plot holders who had opted for payment in installments and have not paid all the installments may also make the payment of balance amount in lump-sum and avail the benefit of the scheme.
- (e) The cases covered by any agreement under any previous policy of the Department prior to 02-4-1987 will not be covered under this scheme.

The scheme will remain operative till 31.03.2012. This issues in anticipation of confirmation of the minutes of the meeting. ZROs/ Addl. ZROs are accordingly informed to organize Site Recovery Camps in co-ordination with RWAs.
