IDEMNITY BOND/UNDERTAKING

1. Application on plain paper with court fee of Rs. 1.25
2. Affidavit of the applicant on Rupees Ten Stamp Paper duly attested.
3. Indemnity bond of the applicant on Rupees 100/- stamp paper duly attested
4. Photograph of the applicant pasted on Indemnity bond.
5. Photocopy of the I. Card, self attested.
6. Photocopy of the Pan Card, Self attested.
7. Cancelled cheque to show the account no. and bank details.

Process for disbursement of awarded compensation

- 1 Immediately after taking over of possession the successful interested person should file an application along with above mentioned documents to the office of the LAC concerned.
- 2 After receiving the application same is scrutinized by the LA Branch and forwarded to accounts Branch for scrutiny and disbursed payment .
- 3 The process takes 15 days in disbursed payment.
- 4 After making payment necessary entries are made in the record.
