CIRCULAR

Sub:- On line submission of details of un-recognized schools.

As per **section-18 of Right of Children to Free & Compulsory Education Act 2009**, "No school other than a school established, owned or controlled by the appropriate Government or the local authority, shall, after the commencement of this Act, be established or function, without obtaining a certificate of recognition from such authority, by making an application in such form and manner, as may be prescribed"


It is observed that number of societies/ trusts/ organizations are running unaided-schools in Delhi without any recognition and are violating the provisions of RTE Act -2009 & DSEAR'73.

Therefore , it is brought to the notice of all such societies/ trusts/ organizations that such violation may attract penal action under section 18 (5) of RTE Act 2009 which may include fine upto one lakh rupees and in case continuing contraventions , to a fine of ten thousand rupees for each day during which such contravention continues.

The Directorate of Education, Govt of NCT of Delhi proposes to collect the data of such unrecognized unaided – schools and details of the infrastructure and land-area etc. available with them for considering a policy formulation on relaxation of norms and standards for recognition.

In view of the above, all the Societies/Trusts/Agencies/Organizations, running unaided- schools in Delhi, which are not recognized by Directorate of Education, are hereby requested to register themselves with the department. It is requested to furnish the requisite information in **prescribed Proforma on-line available on scroll side of the official web-site i.e. www.edudel.nic.in** of the Directorate of Education, Govt. of NCT of Delhi . Such schools have to apply separately for recognition to the Directorate of Education, Govt. of NCT of Delhi. Recognition will be granted only to those institutions which fulfill the requirements & provisions of recognition as per RTE Act, 2009 & DSEAR, 1973.

The last date of submission of on-line information on the prescribed proforma is **1st March 2011**.


