The Vocational Education Branch, Directorate of Education, GNCTD, has been registered as Vocational Training Provider (VTP) by Directorate General of Employment & Training (DGE&T), Govt. of India, to conduct the Modular Employable Skills (MES) Training in different trades & intends to outsource the following 06 courses through Registered VTPs under Skill Development Initiative Scheme (SDIS):

The training under these courses shall be imparted in the Govt. Schools scattered all over Delhi, having Laboratory Facilities, under Directorate of Education, during the Summer Vacations - 2011 (w.e.f. 11<sup>th</sup> May to end of June, 2011). The Assessment & Certification will be done by third party recognised by DGE&T.
