A brief note on the eligibility criteria and details of the financial assistance available to sportspersons under the scheme is enclosed.

TALENT SEARCH AND TRANING SCHEME

The Scheme relating to Talent Search and Training in the Ministry of Youth Affairs & Sports provides financial assistance to promising eligible sportspersons for training and participation in competitions etc. The salient features of the scheme is given as under:

- 1. Purpose: The assistance can be availed for the following purposes:
 - (i) Training and participation in tournaments abroad
 - (ii) Training and participation in tournaments in the country
 - (iii) Purchasing Equipment
 - (iv) Availing Scientific Support
- 2. Amount of Scholarship: Maximum Rs 5 Lakhs
- 3. Eligibility: Sportspersons with following achievements shall be eligible to apply:
 - (i) Those sportspersons who have either equaled or excelled the existing National Record
 - (ii) Gold Medalists of last National Championship
 - (iii) Medalist of Asian Games/ Commonwealth Games/Olympic Games/World Championship in the relevant category, i.e. Senior/Junior/Sub–Junior in Sports disciplines covered under 'Priority' and 'General' category.
 - (iv) For team events assistance will be provided based on an objective assessment of the performance in the National Championships.

4. Age Limit:

- (i) Age of the applicant should not exceed 25 years
- (ii) For sports like Shooting, Golf, Billiards & Snooker, Chess and Yachting the age limit may be relaxed up to 35 years
- (iii) For sports persons winning medals in international events last held, upper age limit may be suitably relaxed.

Component wise ceilings of financial assistance:

- (a) Passage Cost: Economy Class air passage by shortest route both ways from the place of residence in India to the destination along with incidentals, such as airport tax, visa fee, other taxes/fees of mandatory nature and local transport
- (b) Boarding and Lodging:

For training abroad:

- i) In case of training for less than 30 days: Up to USD 100 per day
- ii) In case of training for more than 30 days: Up to USD 1000 per month

For training in India:

- i) Not exceeding Rs 3000 per day for coach
- ii) Not exceeding rates approved for national athletes attending national coaching camps for players

Dedicated coach attached to the sports person, will be similarly assisted for accompanying the sports person, if felt necessary.

- (c) Coaching Fee: Assistance for training and coaching will be provided based on the expertise of the institution/individual coach, recommendation of the sports federation of the concerned country/ report of the Indian Embassy abroad and such other factors as deemed necessary.
- (d) Incidentals: The sports person will be assisted for hiring infrastructures required for training/coaching. Fees for medical/health insurance and other incidentals specifically required for the participation shall also be released as per actuals.
- (e) Equipment: The Sports person will be assisted for purchasing required equipment, both non-consumable and consumable on a realistic basis, for an amount not exceeding US \$750 per year.
- (f) Scientific Support: The sports person will be assisted for scientific support as per the actual not exceeding US \$ 100 per month.
- (g) Maximum Assistance: The assistance under the scheme is limited to Rs 5.00 lacs in individual cases in a particular year.

6. Details/Documents to be submitted for availing financial assistance under the scheme:

- i) Certificates in support of sports qualification
- Details of financial assistance sought for travel, equipment, coaching, hiring of sport infrastructure
- iii) Relevant documents from the coach or the academy concerned, indicating the details of coaching fee, Board-lodging etc charged by them
- iv) Letter from the academy/coach indicating the probable dates of course/coaching
- Details of financial assistance mobilized (received and/or assured) from all other sources like the employer, sponsor, promoters, both in the private or public sector
- vi) Profile/resume of the academy/coach along with justification for selecting the particular academy/coach
- vii) Benefits expected to be derived from the training
- viii) Targets set by the player for himself/herself after completion of the training
- ix) Recommendation from the Sports Authority of India and the National Sports Federation Concerned may also be attached

7. General

- Mere fulfillment of eligibility shall not confer upon the sportspersons, the right to receive financial assistance under the scheme.
- Assistance not exceeding Rs.5 lakhs (Rupees Five lakhs) in a particular year will be awarded only after due consideration of merits of the sports person and availability of funds
- Spreading-over beyond a year will be permitted on case to case basis subject to overall ceiling of financial assistance admissible
- Level of performance of the sportsperson in the identified sports discipline at the time of seeking assistance as well as the expected level of performance (quarterwise) will be taken into account while considering such proposals.
- Performance of the sports person, assisted under the scheme will be reviewed with reference to the target fixed, on quarterly basis, with the help of the Sports

Authority of India, In the event of the sports person's failure to achieve the target without any valid reasons, sanction of further assistance to the sports person can be discontinued.

- In case progress of the sports persons undergoing coaching/training abroad is
 found to be unsatisfactory or if there is any adverse report regarding conduct of
 the sports person, the Ministry shall have the right to cancel the assistance and
 recall the sports persons to India immediately. Performance of the sports person
 assisted under the scheme will be reviewed by the Selection Committee
 constituted.
- After the package of assistance is sanctioned, the promising sports person shall have to execute an agreement with the terms and conditions
