Circular

The Election Commission of India has ordered a Special Campaign to cover the entire eligible population of Delhi by enrolling them and giving them Voter Identity Cards.

This campaign is called the Special Summary Revision of Electoral Rolls.

All persons who are ordinarily resident in Delhi and who shall be 18 years of age or more as on 01.01.2012 are eligible.

All Principals of Private and Aided Schools in Delhi are hereby requested to obtain the necessary Form-6 from their nearest office of Voters' Registration and EPIC Centre (VREC) or nearest Designated Location concerned and ensure that all the students of their schools who shall be 18 years of age or more as on 01.01.2012 fill in this Form. The addresses of the VRECs and Designated Locations can be obtained from the website of the CEO Delhi i.e. www.ceodelhi.nic.in

One passport size photograph is to be stuck on the form at the required space.

All the students are required to submit the proof of date of birth and the proof of residence. In support of proof of address of their residence, they may also submit a copy of Voter Identity Card of one of their parent.

These students can also be motivated to fill the application for inclusion of their name in the Electoral Rolls in Form-6 online on the website of Election Department i.e. www.ceodelhi.nic.in

The Principals of Private and Aided Schools can also contact the District Election Officers / Deputy Commissioners for obtaining blank Form-6 and for submission of duly filled Form-6 in respect of the students of their schools. They may also obtain the posters and leaflets from them for display in their schools.

The last date for receipt of filling and submission of Forms under this special campaign is 1st November, 2011.
