The Election Commission of India has ordered a Special Campaign to cover the entire eligible population of Delhi by enrolling them and giving them Voter Identity Cards.

This campaign is called the Special Summary Revision of Electoral Rolls.

All persons who are ordinarily resident in Delhi and who shall be 18 years of age or more as on 01.01.2012 are eligible.

All Principals of Delhi Government Schools are hereby directed to obtain the necessary Form-6 from their Education Officer / Deputy Director concerned and ensure that all the students of their schools who shall be 18 years of age or more as on 01.01.2012 fill in this Form.

One passport size photograph is to be stuck on the form at the required space.

Since they are students of a Delhi Government School, separate proof of age and proof of residence as mentioned in Form-6 will not be required. However, the Principal should sign the certificate given below:

<p><b><u>Profoma-I</u></b> (to be attached with every application)</p> <p>The applicant .....S/o/D/o..... bearing I.D. No..... is a student of this school. This certificate shall be stapled to the top of every application in Form-6.

All District Election Officers / Deputy Commissioners will be distributing copies of Form-6 alongwith posters and leaflets to the Deputy Directors. The Deputy Directors and EOs shall ensure that these reach all the Principals.

The last date for receipt of filling and submission of Form-6 under this Special Campaign is 1<sup>st</sup> November, 2011. Immediately after that, all Principals should give a certificate to the Education Officer concerned in the following proforma :-
