The terms of reference (TOR) is appended herewith

Offers are invited from Govt./PSU/Reputed Technical Institution/Organization (hereinafter referred to as 3rd Party Consultants) to undertake the Third Party Quality Assurance Consultancy Work as per the Details provided in the TOR. The consultant needs to submit their bids in two envelopes as per details given below so as to reach the office of undersigned upto 03:00 p.m. on 21.11.2011. The Technical Proposals (Envelope I) shall be opened at 04:00 pm on the same day in which the consultant or his duly authorized representative can be present, if so wishes to be. The date of opening of Financial bids (Envelope II) of all the qualified consultants shall be intimated later.

Envelope I:

- Earnest money for an amount of Rs. 2.00 Lakh in shape of Bank Guarantee, FDR or Demand Draft
 in favour of UEE Mission, Delhi, payable at Delhi. The Deposit at CALL or FDR should have a
 validity upto 06 months.
- Details of previous experience in having provided similar services as Third Party/ Independent Quality Assurance Consultancy Services.
- Details of CV's of personnel's proposed to be posted on projects.
- Brief Methodology for Quality Assurance to be adopted.

Envelope II:

- Consultancy Fee as per percentage estimated cost of the project.
- Note 1. The rates quoted should be inclusive of service tax and all other applicable taxes.
- Note 2. The Payment will be made according to the actual work done by Contractors applying the quoted rates.

Terms of Reference (TOR)

Sarva Shiksha Abhiyan (SSA) is a flagship programme of the Govt. of India, an effort to Universalize Elementary Education in response to the demand for quality basic education all over the country. In Delhi, the programme is being run by the Office of the UEE Mission, Lucknow Road, Delhi.

One of the important components of SSA is Civil Works which includes construction/ providing new schools, additional classrooms and other facilities to achieve the objective of the scheme.

Presently, the following Civil Work is awarded/ in the process of award.

Note: The approximate cost of the Civil Work Project involving 3rd Party Evaluation work is about ₹ 17.00 Crore as the work on 3rd Party Evaluation will be carried out on random selection of sites to the extent of 25% of Site.

OBJECTIVES

The main objectives of the services are:

1. To ensure that all the works carried out under this programme fully comply with engineering designs, technical specifications, drawings, established codes & sound engineering practices and contract documents. The main objective of this assignment is to obtain independent and objective assessment of the technical quality of all the construction works.

2. Scope of 3rd Party Consultant's Services

The scope of 3rd Party Consulting Services will include the following: -

- i. Review design, estimates and to identify shortcoming, omission, inconsistencies and ambiguities in details engineering.
- ii. To finalize quality assurance documents namely the quality plans, inspection and test plans (ITP) forms, reports, etc., as per requirements of the project and ensuring the implementation.
- iii. To conduct Technical audit on total testing done by the Contractors/executive agency and issue non-conformance report proposing appropriate corrective and preventive actions to the Contractor/executive agency and the SSA office.
- iv. To assist the client in approval of the field testing laboratories set up by various contractors/ executive agencies in respect of its facilities, adequacy, arrangements, equipment and laboratories staff etc.
- v. Review suitability of source and quality of construction materials on the basis of inspections, test results/manufactures certificates etc.
- vi. Develop forms and procedures in order to ensure implementation of a proper Quality Assurance System on all activities and aspects of the project.
- vii. Assist the Engineer on matters connected with the quality assurance / control aspect of works in order to insure the quality of work and its conformity with the standards & specifications prescribed in the contract.
- viii. During course of inspection if any item of the work is found substandard or unacceptable, the 3rd party consultant would inform the Contractor/ Executive agency, Engineer concerned and client about rectification required in writing, giving full justification thereof with necessary supporting data.
- ix. The 3rd Party consultant will inspect the works on the following stages of construction:-
 - I. Foundation Level

- II. Plinth Level
- III. Roof Level
- IV. After Completion

3. Data Services and Facilities to be provided by the Client

The following services, facilities and data shall be provided by the SSA office/Executive agency

(a) Service Data:

- (i) Copy of the project reports including detailed engineering, designs and estimates.
- (ii) Copy of the contract documents containing conditions of contract, contact specifications drawing etc.
- (iii)Status reports of various works from time to time to facilitate inspection of various works as the schedules provided in this agreement hereinabove.

(b) Laboratory:

Fully finished and equipped filed testing laboratory including manpower will be arranged by the contract for each construction. The 3rd Party consultant will have free access to use testing facilities at site. In case, if any laboratory is not provided at any site, then the necessary testing is to be done in approved laboratories. However, sampling of the material etc for the necessary testing should be done jointly by the contractor in the present of the 3rd Party Consultant. Wherever the sub-standard quality of material and work is noticed or doubts arise tests should be conducted for such items also without any additional charge. However, if any special testing is to be done at the instance of the client, the payment towards laboratory charges shall be made by the client or contractor.

4. Payment of the Work to be carried out

The payment to be 3rd Party Quality Assurance Consultant shall be made in 2 stage as per the followings schedules for each package/ works/ site.

5. Schedule for completion of various Tasks

The Consultant shall setup the project office and start the work immediately in respect of ongoing works and simultaneously with the start of work in respect of proposed projects.

6. Specific Tasks to be approved by the Client

On review of project reports, designs, contract documents, alternation or modifications as proposed by the 3rd Party consultant, the same will require prior approval of the SPD-SSA. For this purpose the 3rd Party consultant shall substantiate with reasons the proposed changes/modifications/alterations.

7. Final Outputs of Consultant's Services.

- a. The 3rd Party Consultant shall submit to the SSA office 2 copies of the following reports. The language of reports shall be English.
- b. Inspection report within 10 days from the commencement of services. This report shall contain detailed approach step by step of methodology of providing services work plan, deployment of key personnel and details of mobilization of Consultant office.
- c. Quality Assurance Plans within 10 days of start of assignment.
- d. Monthly Progress Reports summarizing the progress & quality of construction work for each package inspected during the month, the technical problems encountered at site and suggestions for improvement in design & construction. These reports shall be submitted no later than 15th of the following month.
- e. Inspection Reports for each package/Location at various stages of construction inspected by the 3rd Party consultant as per the schedule of inspection provided hereinabove in this agreement.

8. Indicative Staffing Requirement and Qualifications.

8.1 Key Personnel:

Typically, the following key positions are evaluated for this assignment.

- a) Team Leader/Senior Quality Assurance Engineer
- b) Quality Control Specialist

8.2 Qualification & Experience of Key Personnel

- a) Team Leader/ Senior Quality Assurance Engineer- the person should have Bachelor's Degree in Civil Engineering or equivalent with a minimum 15 years experience including atlest 3 years experience on devising and guiding Quality Assurance programme on Building work projects. The candidate should be able to formulate quality assurance plans for achieving high quality in construction work. He should be capable of carrying out inspection of contractor's equipments, plants, machinery and methodology etc. and checking and verification of setting out data for the work including line levels and layout to ensure conformity with the working drawing. He should be able to guide and monitor the team of field staff engaged in quality control programme.
- b) Quality Control Specialist- The person should have Bachelor's Degree in Civil Engineering with 5 year experience or diploma in civil engineering with 10 years experience with a minimum 2 years of experience related to inside and laboratory testing of all construction material for building work projects.

9. TERMS & CONDITIONS

- a. The Office of the UEE Mission, Delhi shall select a Third Party Quality Assurance Consultant who shall be selected on the basis of having provided/ providing similar services in the last 3 years on at least in 3 projects comprising Construction of Building/ Urban Developments.
- b. The Third Party Quality Assurance Consultant shall enter into an Agreement with the Office of the UEE Mission, Delhi as per format appended herewith.
- c. The payment to the Third Party Quality Assurance Consultant shall be on p*rorata* basis as per the payment schedule provided in the TOR within 30 days of submission of bills.
- d. Third Party Quality Assurance Consultant shall be provided with the copy of documents/ Agreements with the contractors for the work.
- e. 3rd Party Consultant needs to provide Performance Security amount of Rs. 2,00,000/- (Rs. Two lacs) in the form of FDR/DD/ Bank Guarantee in favour of SPD, UEE Mission, Delhi within 15 days of issue of letter of Intent issued by the Office of UEE Mission, intimating the award of the consultancy work.
- f. In case the office of UEE Mission Delhi has the reasons to believe that the Third Party Quality Assurance Consultant is not discharging their duties in a fair, appropriate and diligent manner, a meeting with the Consultant and office of UEE Mission shall be held by the SPD, UEE Mission to resolve the issue amicably and 3rd Party consultant shall be given a fair hearing. In the event of any disagreement or difference between office of SPD and 3rd Party consultant in the matter the same shall be resolved through the intervention of Secretary Education cumchairman SSA.
- g. The UEE Mission shall have the authority to accept or reject any or all offers received from the Consultants.
- h. The UEE Mission reserves the right to cancel or rescind the project at any level without assigning any reason before entering into Memorandum of Understanding with 3rd Party consultant.
- i. In any eventuality of the project not being executed by the construction agency, the 3rd Party consultant can have no claim with the office of SSA for any payment except to ask for withdrawal of FDR/DD/Bank Guarantee.
- j. The validity of percentage rate of consultancy charges is for one year and further extendable on yearly basis on mutual consent upto three years.
