I am directed to forward herewith the letter no F.2/21/2007/S.I/2171 dt.05/04/11 of the Spl. Secretary (Services) GNCT of Delhi referring a letter no. IG/CCETC/09/34/2278 dated 02/02/11 of the Professor, OSD & Coordinator, IGNOU, on the above mentioned subject along with the letter no 11030/01/2010-Trg.1 dated 24/1/2011 and the OM No.11030/01/2010-Trg.-1 of Govt. of India, Ministry of Personnel, PG & Pension Department of Personal and Training, Training Division dated 22/12/10 for further information and necessary action at your end.

It is regarding the course offered by IGNOU under the Distance & E Learning Programme for Govt. Employees- (DELPGE) in partnership with DOPT, and the clarifications given by DOPT on the issue " **whether prior permission of competent authority**" is necessary for enrolment in the programme by govt servant.

DOPT has issued general instructions that:

- (i) specific permission of the controlling authority is not necessary prior to enrolling in the course/programme offered under DELPGE ;
- (ii) An employee/officer enrolling for the programme under DELPGE shall be required to give an undertaking to the Deptt/Ministry/office concerned incorporating inter-alia the following :-
 - (a) the programme /course shall be pursued by the Govt savant/ officer beyond the office hours ;
 - (b) Application shall be made to the controlling officer for grant of leave, as admissible, if the examination/assessment pertaining to course/programme undertaken under DELPGE happens to be on a working day.


