The 34th All India continuing educational programme of the Hospital Pharmacists will be held from 10th to 15th October, 2011 at St. Stephen's Hospital. The delegates will be exposed and encouraged to participate in:

- Eligibility :** Registered Pharmacists having diploma or degree in pharmacy and working in supervisory position in hospitals and dispensaries, teachers, M. Pharm. Students in Hospital Pharmacy, Pharmacy Practice, Pharmaceutics & Pharm D, may apply / may be sponsored.

Fees:- The delegation fee will be Rs. 3000/- (Rupees Three thousands only). The crossed Demand Draft drawn in favour of "Indian Hospital Pharmacists Association, New Delhi" may be sent at the above mentioned address in advance.

Delegates will make their own arrangement for boarding and lodging. However arrangement will be made for some delegates for their stay if informed earlier to the course director. The payment will be made by the candidate.

A Certificate of participation will be issued to each participant and it will be recognized for renewal of registration by State Pharmacy Councils, as the Pharmacy Council of India is going to make it mandatory that each Registered Pharmacist must attend two refresher courses in a span of 5 years for the renewal of their registration to be conducted by the IHPA or by any other professional organizations or pharmacy colleges of the states.
