OFFICE MEMORANDUM

Subject : Communication of sanction in case where the Secretary of a Ministry/Department approves a proposal by overruling the concerned Financial Adviser – Further clarification reg.

The undersigned is directed to refer to this Department's O.M. of even no. dated 7th October, 2010 on the above cited subject, wherein, it has been stipulated that in cases where the Secretary of a Ministry/ Department has over-ruled the concerned Financial Adviser, the clause to be added to the sanction letter in the context of Rule 25 of the Delegation of Financial Powers Rules, should read as follows:-

Ke me ceru... "This sanction issues with the approval of the Chief Accounting Authority. The advice of Internal Finance/Integrated Finance was conveyed vide Dy. No./UO No..... dated....."

2. It has come to the notice of this Department that the aforesaid provision is being used by Ministries/ Departments even in cases which do not fall in the delegated powers of the Ministry/ Department. In this context, it is clarified that the Secretary of a Ministry/ Department can overrule the Financial Adviser only in respect of cases which fall within the financial powers delegated to the Secretary of the Department. The question of overruling the Financial Adviser in other cases of higher value needs to be considered by the appropriate Competent Financial Authority in terms of extant delegation of financial powers.
