ORDER

Sub:- **Revision of delegation of powers for sanction of capital works.**

In supersession to all previous orders regarding delegation of powers for sanction of capital works, the Lieutenant Governor of Delhi is pleased to enhance the financial powers of different authorities for approval and sanction of capital projects of Delhi Police in the following manner.

Sr. No.	Sanctioning Authority	Existing Financial Powers	Enhanced Financial Powers
1.	Commissioner, Delhi Police	Upto Rs. 85 Lakh	Upto Rs. 1.50 crore
2.	Home Secretary	-Nil-	Above Rs. 1.50 crore and upto Rs. 2.00 crore
3	Finance Department , Government of NCT of Delhi	Above Rs. 85 Lakh and upto Rs. 5 crore	Above Rs. 2.00 crore and upto Rs. 10.00 crore
4.	Standing Finance Committee	Above Rs. 5 crore	Above Rs. 10.00 crore

2. The decision making/sanctioning authorities shall consider/approved the proposals for capital works as per standard norms and subject to the following parameters.

- (i) The estimates shall be prepared at DSR/DPAR-2007. Cost of index shall be allowed at @ 9%. Contingencies, labour cess, art works, third party quality control shall be allowed @1% each.

- (ii) Consultancy charges shall be fixed subject to a maximum of 3% on the original cost. It shall not be revised unless there are substantial changes in the scope of work by way of additions to the project.
- (iii) Project management charges/Departmental charges shall not exceed 5% of the original project cost.
- (iv) Proposal shall not be sub-divided for convenience of sanction at lower level.
3. This order comes into force with immediate effect.
