CIRCULAR

Sub:- Submission of Annual Returns for the year 2011-12 for implementation of RTI Act, 2005.

I have been stressing from time to time that the Quarterly/Annual Return of Right to Information under section 25 of the Right to Information Act, 2005 should be uploaded on the website of CIC well in time but unfortunately this is not being done, despite repeated reminders issued by AR Department. The CIC has again brought to my notice that 29 departments as per list enclosed are still defaulters. The CIC has fixed 20th July 2012 as the last date for uploading the Quarterly Return, as such the needful should be done by the concerned departments by this date, failing which the CIC has proposed to go ahead and submit the Annual Report to the Parliament highlighting the names of defaulter public authorities.

2. All concerned departments are accordingly directed to comply with the directions of Central Information Commission and send a compliance report to AR Department by 20th July, 2012.
3. All Pr. Secretaries/Secretaries and Heads of Departments are directed to ensure that the Quarterly Return in respect of their departments are uploaded on the website of Central Information Commission well in time and there should be no cause of complaint from CIC in this regard.
