I am directed to invite your kind attention to this office circular of even number dated 12/04/2012 on the subject mentioned above. As per the recommendations of Second Administrative Reforms Commission, the Government should provide training in Right to Information Act, 2005 to all the officers and staff members including Group D and also with a view to encourage them to get acquainted with the provisions of "Right to Information Act, 2005" and use the knowledge so gained in their day-to-day working, it has been decided to launch a scheme of "Self Learning of RTI Act, 2005".

- 2. It is further informed that the last date for submission of application in AR Department has been extended to 31st August, 2012. Applications from desirous candidates may please be forwarded to Administrative Reforms Department in the enclosed proforma, (also available in the website of this Department i.e. http://ar.delhigovt.nic.in) duly completed in all respect, latest by 31st August, 2012. Those who have already applied for the test need not apply again. The test is likely to be held in the last week of September, 2012. The exact date, time and venue of the test will be intimated in due course. In case, the roll numbers for the test are not received by mid-September, concerned candidate may obtain the same from A.R. Department, in person.
- 3. It may kindly be ensured that the contents of this letter is brought to the notice of all officers/officials, including Group D staff of your Department/ Organization and its subordinate/attached offices, so that maximum number of officers/officials could be able to participate in the test. A copy of the circular issued may please be enclosed to AR Department also.
