2. National e-Governance Division (NeGD) , Department of Electronics & Information Technology (DEIT) , Government of India has constituted State e-Governance Mission Team (SeMT) in all States and Union Territories to **provide technical and managerial consultancy services** to the State Government for the projects under National e-Governance Plan ( NeGP) and other major State e-Governance initiatives in the direction to fulfil the vision of NeGP:-

*"Make all Government services accessible to the common man in his locality, through common service delivery outlets, and ensure efficiency, transparency, and reliability of such services at affordable costs to realise the basic needs of the common man"*

3. As per the DEIT- Govt. of India guidelines, State e-Governance Mission Team- Delhi (SeMT-Delhi) will function as full-time internal advisory body in undertaking e-Governance projects and advising high level committees on IT/e-Governance. The team would be responsible for providing an overall direction, standardization, consistency through program management of the e-Governance initiatives in the State and alignment with the overall objectives of National e-Governance Plan (NeGP).

4. SeMT -Delhi is comprising of seven(7) consultants with varying level[Head SeMT-Cum-Principal Consultant, Senior Consultants and Consultants] having institutional knowledge on e-Governance and are having expertises in the following areas/functions:-

- i. Program Management
- ii. Financial Management
- iii. Technology Management
- iv. Change Management

5. Delhi e-Governance Society (DeGS), GNCTD will act as State Designated Agency for implementation of National e-Governance Plan in Delhi State. State e-Mission Team (SeMT) will function as part of Delhi e-Governance Society (DeGS). Departments are advised to consult SeMT-Delhi, through Secretary(IT)/CEO(DeGS) for :-

**a) Mission Mode Projects**

- Initialization and implementation of State Specific and integrated e- Governance Mission Mode Project(MMP) of Government of India,
