CIRCULAR

As per the provisions of the Right of Children to Free and Compulsory Education Act 2009, it is mandatory that all recognized unaided schools shall admit children belonging to the Economically Weaker Section & Disadvantaged Group Category in Class I to the extent of, at least, 25% of the strength of the class and where a school imparts pre-school education, the provision shall apply for admission to that class and free education shall be provided by these schools to such children.

The government is bound to reimburse the expenditure incurred in respect of such students as per the provisions of sub section (2) of Section 12 of the RTEA 2009 read with rule 11 of the Delhi Right of Children to Free and Compulsory Education Rules 2011.

Attention of all Recognized Un-Aided Schools is invited to Clause 7(g) of Notification No. 15(172)/DE/Act/2010/69 dated 07-01-2011 vide which all such schools are required to submit details of students admitted under Economically Weaker Section & Disadvantaged Groups category in ANNEXURE IV of the said Notification. It is observed that many schools have not submitted the requisite information despite reminder circular issued on 31-10-2011.

Managers/Principals of all recognized un-aided schools in Delhi are hereby directed to submit the per child expenditure incurred by them in the Session 2010-11 by way of an Affidavit (in the enclosed format) attested by a Public Notary/Oath Commissioner. The affidavit should be submitted in the office of District Deputy Directors in whose jurisdiction the school falls. In addition to the Affidavit, the information with regard to the students admitted by the school in entry class should also be submitted in the enclosed format (Annexure – A).
