

The recommended proposals will be placed before the competent authority i.e. Executive Committee and Governing Body of SSA, Delhi, for further approval. However, the decision of the Secretary (Education) cum Chairperson, EC- SSA will be final in this regard and no complaints whatsoever shall be entertained.
