

SELECTION TRIALS FOR PARTICIPATION OF DELHI BADMINTON AND  
JUDO TEAMS IN INTERNATIONAL TOURNAMENT

The Tokyo Metropolitan Government, The Tokyo Sport Benefits Corporation, the Tokyo Badminton Association and the Judo Federation of Tokyo will be hosting the “Asia Junior Sports Exchange Games 2012” to be held from the 28<sup>th</sup> of August to 3<sup>rd</sup> September, 2012 in Tokyo.

This Government intends to nominate its Badminton and Judo teams for participation in these Tournaments.

Badminton:- The city team will consist of 06 players (03 boys and 03 girls). The player should be under – 16 years old (born after January 1, 1997). Certificate and medals will be awarded to the winner, the runner-up and 3<sup>rd</sup> place.

Judo:- The city team will consist of 08 players (05 men and 03 women) in the following weight category:-

Men:- - 60 kg., -66 kg., -73 kg., -90 kg., over 90 kg. (open)

Women:- - 52 kg., -70 kg., over 70 kg. (open)

**Note:- For judo trials in above category, minimum requirement of weight in each category is as below:-**

Men:- 56 kg., -66 kg., -73 kg., -90 kg., +90 kg.

Women:- + 48 kg., +61 kg., +70kg.

Judokas (Men and Women) should be born between 2<sup>nd</sup> April, 1994 and 1<sup>st</sup> April 1997.

In case of weight category of over 90 kg men and over 70 kg women, the weight will be relaxable by 2 kg., if less than 3 players compete in each category. In other weight categories, relaxation upto +1 kg. may be allowed in the preliminary selection trial only.

There shall be no relaxation in prescribed age under any circumstances.

Each player shall assume all responsibilities for accident and health insurance as well as civil liability. The insurance must have coverage that includes Japan. This government shall not be responsible of liability of accident, illness, injury and death of any participant.

Tokyo Metropolitan Governments shall bear:-

1. Round trip economy class air tickets between the International Airport of New Delhi and Narita Airport.
2. Expenses for a 6-night (7 days) stay at an accommodation which it will designate. The costs of all food and drink not included in the break fast, lunches, and dinners etc., provided by them shall be borne by the player.
3. Local transportation expenses in Japan for the matches will be provided by them. All travel expenses for personal travel not included in the tournament scheduled shall be the responsibility for each participating player.

All other expenses shall be borne by the respective participating individual player. Accordingly, the entries are invited from the desired players who fulfill the above criteria for participating in selection trials. The participating player for selection trial should be a bonafide resident of Delhi at least for three continuous years as on the date of trial. The entries are to be submitted, strictly in prescribed Entry Form, along with supporting documents mentioned in the Check List. The entry may be deposited in Chhatrasal Stadium, Model Town during office hours upto 9<sup>th</sup> June 2012.

The list of successful candidates for preliminary trials shall be displayed in Chhatrasal Stadium on 11<sup>th</sup> June 2012 at 5.00 p.m. The preliminary selection trials for badminton shall take place from 14<sup>th</sup> June, 2012 at 10.00 a.m. in the Badminton Hall of Ludlow Castle Sports Complex, Delhi -54. The preliminary selection trials for Judo shall take place on 14<sup>th</sup> June 2012 at Chhatrasal Stadium, Model Town. For Judo, the official weights shall be taken at 10.00 a.m. on 14<sup>th</sup> June, 2012 at Chhatrasal Stadium, Model Town.

The players shall bring their own playing equipment and will participate in proper playing kit at their own risk. The badminton trials will be organized on Wooden Courts. However, shuttle cocks shall be provided by this department. Strict discipline shall be maintained during the trials and no indiscipline shall be acceptable.

**The date for the final selection trials will be intimated in due course.**  
**In final selection trials, no relaxation will be allowed in any weight category in Judo under any circumstances.**

The Department of Education reserves the right of final selection of the teams and its decision shall be final. In case of any dispute, the decision of the Department of Education will be final.

## CHECK LIST

### DOCUMENTS TO BE SUBMITTED :-

1. Entry form, duly filled-in all the columns & signed by the Head of the School / College where the student is at present studying. (Incomplete form will be rejected). In case, any player is not studying anywhere, then the Entry form is to be got attested by a Gazetted Officer.
2. Attested copy of Date of birth certificate issued by MCD/NDMC.
3. Attested copy of proof of continuous residence of player in Delhi for the last 3 years prior to the date of trials. The residence proof should bear the name of the player.
4. Attested copy of passport of player (if passport is not available, the photocopy of receipt of Passport form submitted in Regional Passport Office)
5. Attested copy of class X & class XII certificate (wherever applicable)
6. Details of participation in Delhi state and National tournaments in the last 3 years along with attested copies of supporting certificates.
7. Attested copies of Report Card / Progress report of player for the last 3 academic years i.e. 2009-2010, 2010-2011 and 2011-2012.
