Sub: Promotion of Group 'D' employees in Directorate of Education to the post of Laboratory Assistant.

Consequent upon promotion to the post of Laboratory Assistant in the pay scale of Rs. 1200-2040 (Pre-revised) (revised to 4000-6000) and thereafter revised to Pay Band 1 i.e. 5200-20,200 with Grade Pay Rs.2400/- plus usual allowances as admissible under the rules vide Order No. 4/(8)/(23)/E-IV/10-11/Vol-I/5338-395 dated 28.9.2011, and after having accepted the offer of promotion, the following Group D officials working in various departments of GNCT of Delhi are hereby directed to report, after being relieved from their respective departments to the undersigned, for further assignment, with 10 days of issue of this order positively. **It may kindly be ensured and specifically mentioned in the relieving order that no vigilance case is contemplated / pending against them at any level.** The appointment / promotion of these Group D employees to the post of Laboratory Assistants in this Directorate will be subject to the conditions as indicated in the aforesaid order dated 28.9.2011 of this Directorate.
