

Circular

In the recently concluded survey of Out of School CWSN held w.e.f. 20.06.12 to 20.07.12, a total of 11,348 Out of School CWSN were identified. I appreciate the good work and the sincere efforts made by all involved in the survey work. However, to make the whole exercise meaningful it is imperative that all these children are brought to the mainstream formal education system, so as to enable them to receive quality education at par with other children in an Inclusive Education setup. In this regard special admission drive has been planned w.e.f. 07.11.12 to 15.12.12 for bringing these children to the schools nearer to their residence. During this period all the Resource Teachers will motivate the parents/guardians of the CWSN identified by them during the survey and get their ward admitted in age appropriate class in the nearby DoE, MCD, NDMC & DCB schools. After getting the children admitted, the Resource Teachers have to submit the relevant information eg. Name of School, where admitted, School ID, Class etc. through online module.

The District & Zonal Coordinators(IEDSS) and BURCCs/CRCCs will supervise and monitor the progress of the admission drive in their respective Districts/Zones and will apprise the office of SPD-SSA about the progress. They will also be responsible for holding meetings with the HoS, members of VKS, RWAs, Community Leaders etc. so that all the identified Out of School CWSN are admitted in the schools. 
