Subject: Enplanement of registered Societies and Trusts running Madrasas/Maqtabaswith the Department of Education under SSA for running Special Training Centers.

On behalf of the Department of Education, the UEE Mission (SSA) Delhi, invites proposal from Madrasas/Maqtabas registered societies or trust to open Special Training Centers being run by for Out of School children including those who are enrolled with Madrasas/Maqtabas in the age group of 6 to 14 years.

Funding to all these Special Learning Centers will be as per the norms of SSA as approved by Ministry of HRD, Delhi.

Interested Madrasas/Maqtabas may submit their proposal along with the following documents:

- 1. A copy of registration along with the list of members in the society or trust.
- Certified balance sheet or audit report of the last 3 tears of the Madrasa/Maqtabas.
- A report on the educational projects completed so far by the Madrasa/Maqtabas.
- 4. A clear indication of the plan for the coverage of Out of School Children belonging to Muslim Minority Community.
- 5. Information on how the Madrasa/Maqtabas will implement the intervention(s), the support required from the UEE Mission.
- 6. List of children enrolled with Madrasa/Maqtabas run by the society or trust.
- 7. Justification of why the said Madrasa/Magtabas be selected.

All the proposals received by due date will be screened by the Screening Committee on the basis of the *credibility*, *capability and relevant experience of the Madrasa/Maqtabas in the field as well as submission of relevant documents as per cited above*. The recommended proposals will be placed before the Competent Authority i.e. Executive Committee and Governing Body of SSA, Delhi, for further approval. However, the decision of Secretary (Education) cum Chairperson, EC-SSA will be final in this regard and no complaints whatsoever shall be entertained.
