



C I R C U L A R


In continuation of the Order No. DE.23(363)Sch.Br./704-717 dated 1<sup>st</sup> July 2012 for the closur of schools till 7<sup>th</sup> July 2012.

As per provisions of RTE Act 2009 every school must have 220 working days. In order to complete 220 working days, it has been decided to cover the loss of working days by opening the schools in the month of December 2012/January 2013 for six days 26<sup>th</sup>, 27<sup>th</sup>, 28<sup>th</sup> & 29<sup>th</sup> December 2012 and 14<sup>th</sup>, 15<sup>th</sup> January 2013 for classes 6<sup>th</sup> to 12<sup>th</sup>. The Primary students will not come to school. However it is compulsory for all the teachers to attend school.

Accordingly, the Winter Break is rescheduled from 31<sup>st</sup> December 2012 to 12<sup>th</sup> January 2013. The schools will reopen on 14<sup>th</sup> January 2013.

All schools under the jurisdiction of NDMC/DCB/unaided recognized schools are advised to plan for ensuring that their schools are working for 220 days.


