NOTIFICATION

No. F.12(3)/Fin(Rev-1)/2012-13 In exercise of the powers conferred by sub-section (2) of section 3 of the Delhi Tax on Luxuries Act, 1996, (Delhi Act 10 of 1996), the Lieutenant Governor of National Capital Territory of Delhi, hereby notifies the rate of tax to be levied on the turnover of receipts of the proprietor in respect of luxury provided in establishments, as under:-

S. No.	Establishment	Rate of Tax
1.	Luxury provided in Banquet Hall being run and managed by DDA, MCD, NDMC and Delhi Cantonment Board	Zero
2.	Luxury provided in Banquet Hall other than mentioned at S. No. 1 above	Three percent
3.	Luxury provided in Gymnasium/Health Club	Three percent
4.	Luxury provided in Hotel having tariff of Rs.750/- or above but less than Rs.1000/- per room per day	Three percent
5.	Luxury provided in Spa	Three percent

2. The notifications No. F.12(6)/Fin.(T&E)/2008-09/jsfin/248 dated 22.06.2009 and F.14(12)/LA-2010/lclaw/323 dated 10.09.2010 shall remain in force in respect of hotel having tariff of Rs.1000/- per room per day and above

3. This notification shall come into force with effect from 09th August, 2012.
