Subject:- Renewal of existing BPL foodcards and old AAY foodcards –
Amendment regarding.

Please refer to this office instruction No. F.3(1)/2001/CFS/D/2005/Vol.II/945 dated 05.10.2007 regarding renewal of existing BPL foodcards and old AAY foodcards. In this regard income certificate from SDM was required by all the BPL and old AAY foodcards, which has been dropped and replaced the following condition:

In place of Income Certificate issued from SDM office, the applicant should submit an affidavit stating therein the name, age, occupation and monthly income of all the family members. If the total income is below Rs. 24,200/- per year, they shall be entitled to BPL/AAY cards.

Further to exclude bogus/fictitious ration cards, each card shall be renewed by the FSO or the inspector only on personal appearance of the Head of family whose photo is affixed on the old ration card and also by comparing the signatures on the old ration card and the application form and the affidavit submitted. The FSO/Inspector shall personally maintain a proper record of each card he has renewed. The Assistant Commissioners shall also carry out independent checks to ensure that the signatures tally before sending the renewal application forms to CMC for issue of new ration card.

In case of infirm or sick of Head of family, the Inspector shall carry out a field visit to satisfy himself of the genuineness of the card.

All other terms and conditions of the instructions issued on 5.10.2007 will remain unchanged.
