No dealer shall, at any time store more than above limits. All the Dealers in National Capital Territory of Delhi are hereby informed that the above Stock limits are applicable in National Capital Territory of Delhi.

The above stock limits are not applicable on import of above mentioned commodities. Provided that the Central Govt or State Govt may direct the importers to declare the receipts of stock of these commodities and stock retained by them.

If any person finds anyone storing these commodities beyond the prescribed limit, he may inform to the Control Room, Food & Supplies Deptt, K-Block Vikas Bhawan, New Delhi-02 (Ph No 23370841) or Concerned Circle FSO/Zonal Asst Commissioner.
