Instructions contained in para 1.14 of the guidelines for allotment of PDS outlets circulated vide this office No. F. 28(4)/97-F&S(P&C)/1003 dated 29/8/97 envisage that the Food & Supplies Officers will notify vacancies for fair price shops and Kerosene oil depots and send copies of the notification to the following:-

6. Secretary, All India SC/ST Association, Delhi.
7. Registrar, Co-operative societies, Delhi.
8. PS to CFS.
9. Notice Board, Circle No. Delhi/New Delhi.
10. Office File.
11. Chairman, D.S.C.S.C.
12. Administrator, D.C.C.W.S.
13. A.C. concerned.
14. Director, Information & Publicity, Govt. of NCT of Delhi.

Instances have come to notice that the above instructions are not being strictly followed. This results in restricted availability of the vacancies among those who may seek applications/licences.

Therefore in processing the applications against advertisement of vacancies already issued this aspect may be taken into account and the licencing authorities may ensure that due publicity has been given to the vacancies notified as per the above referred instructions before they

For this purpose it has been decided that, instead of separate endorsement of copies by FSOs, one single advertisement will be released by D.C. (Distt.) on the 3rd and 18th of every month. For this D.C. (Distt.) should request Director of Information & Publicity that the press release should be released in local languages also.

Therefore all zonal officers are requested to ensure that the copies of notification of vacancies for every fortnight reach the office of D.C. (Distt.) by 2nd and 17th of the month.
