### **GUIDELINES FOR INSPECTION OF PDS OUTLETS**

It has been decided that during the inspection of PDS outlets the following guidelines will be followed by the inspecting officer/staff:-

- 1. Introduction through the official Identity Card.
- 2. Deployment order must be shown. (If assigned through Enforcement Branch)
- 3. Physical verification of the stock must be carried out.
- 4. Validity of the licence of the concerned KOD/FPS be checked.
- Recovery of records with proper recovery memo with signatures of inspector and Licencee/Authorisation Holder/Salesman. The last entry may be signed and stamped by the licence/salesman and last issued cash memo may also be got signed and stamped.
- Recording of display of sign board, stock board, notice board, category wise rate list i.e. all the signages + notice board.
- Production of samples of the SFAs.
- 8. Sanitary condition in and around the shop must be checked.
- Recording of statement of the Licencee/Authorisation Holder/Salesman with signatures
  of inspector/checking team also.
- Weighment/measurement and recovery of records with proper acknowledgement regarding receipt of the same by Licencee/Authorisation Holder/Salesman.
- 11. Complaint book will be examined.
- Ensure that the records of PDS outlets is submitted regularly in the circle office for Public Audit.
- 13. Availability/production of all records/books maintained by the PDS.
- Recording of inspection in the inspection book. The signature of the Licencee/Authorisation Holder/Salesman to be got in the inspection book.

#### CIRCULAR

It has come to the notice of the Department that during surprise inspection/visit by the Senior Officers of this Department, a number of FPS/KODs were found closed. The licensee holders of such FPS/KODs deliberately close their shops when they come to know about the inspection/visit of Senior Officers of this Department to avoid any kind of penal action against them, if found violating the provisions of Control Orders. The FPS/KODs are required to remain open everyday between 9.00 AM to 1.00 PM and 3.00 PM to 7.00 PM with Tuesdays as weekly off-day.

Henceforth, if any FPS/KOD is found closed during the scheduled time period, it will be presumed that they are indulging in diversion of stock and pro rata sale for the day of concerned FPS/KOD will be presumed as diverted and FIR will be lodged. Further, on finding the FPS/KOD closed, the shop will be sealed and the same will be desealed by Enforcement/Vigilance team as per procedure and thereafter if any discrepancies are noticed action as per the law will be taken against the FPS/KOD holder, besides launching door to door survey against the same.
