

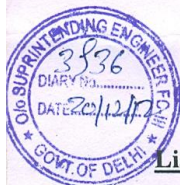

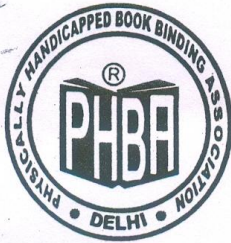


I feel pleasure in introducing you with the physically Handicapped book Bindere Association, in Organisation dedicated to promote the rehabilitation of Handicapped persons.


In continuation of this administration circular letter No. F.13(15)/87-R&I dated 27th August, 1987 on the subject noted above. I am directed to say that the above-said Association has informed about the change of address of their new office to 69-A Institutional Area, Tuglakabad, New Delhi-110062 from their previous office P-322, Kasturba Nagar, New Delhi.

2. The work of Printing & Binding is being undertaken by the physically Handicapped in the said association.

3. The work of printing & binding is also got executed by the Department of Social Welfare by the Physically Handicapped persons of the Training-cum-Production Centre and when the above said Institution fails to undertake the work for one reason or the other, the Departments of this Government entrust this work to the outside local agencies. This is not desirable, preference should be given to the Physically Handicapped Association.

4. I am, therefore, to request that when the Government of India, Printing & Stationery Department or the Training-cum-Production Centre decline to undertake the work and fail to issue NOC within a period of three to four weeks from the date of assignment of the work or no reply is received from Training-cum-Production Centre within stipulated period, the department will be at liberty to place their order to the Physically Handicapped Book Binding Association, 69-A, Institutional Area, Tuglakabad, New Delhi-110062, under intimation to the Training-cum-Production Centre cancelling their order placed with them earlier.
