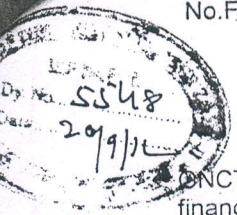

OFFICE MEMORANDUM

During examination of a case of departmental proceedings against an official of NCT of Delhi, who raised heavy amount of personal loan from banking/non banking financial institutions, it was noted that the Drawing & Disbursement Officer concerned had given an undertaking to the effect that in case any portion of the loan remains outstanding against the officer concerned, the same shall be deducted from his terminal benefits. In the said case, consequent to the default of the official in payments, the claimant banking institutions filed suits against the Government for recovery of the loan from the Drawing & Disbursing Officer.

The Lt. Governor, Delhi has taken serious note of such action on the part of Drawing & Disbursement officer and ordered that henceforth, no officer/official should invite any obligation on part of the Govt. by giving any undertaking for effecting deductions from the salary to service repayment of non Govt. loans obtained by its officials.

Accordingly, it is hereby brought into the notice of all concerned that no officer/official should invite any obligation on part of the Govt. by giving any undertaking to any banking or non banking organization for effecting deductions from the salary of Govt. servants to repay his EMI towards non govt./personal loan obtained from above said organizations.. Govt. role will be limited to exercising its powers over the Govt. servant entering such transactions, under the provisions of CCS (Conduct) Rules, 1964. These instructions should be strictly followed.
